

ARTICLES OF INCORPORATION  
OF  
MIT ACADEMY  
A CALIFORNIA PUBLIC BENEFIT CORPORATION

ONE: The Name of this Corporation is MIT Academy.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. This corporation has no members. It is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. The specific purposes for which this corporation is organized are to provide innovative, outcome-based education for students in grades 6 – 12 and who live in State of California.

THREE: The name and address in the State of California of this corporation's initial agent for service of this process is Lynne Vaughan 110 Kim Court, Vallejo, CA 94591.

FOUR: (a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

- (b) Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.
- (c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, public entity, or corporation which is organized and operated exclusively for public or independent educational institutions which have a similar mission and purpose and which serves students in grades 6 – 12 in the greater Vallejo area, and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
